With respect to one-half or whole cow purchases, an <u>Additional Deposit of \$750.00</u> shall be paid to Farm not less than five (5) days from notice being provided to Buyer by the Farm as to the scheduled date of processing and prior to Transportation and Delivery of Cattle to Processor.

a. A Deposit equal to $\frac{1}{3}$ of the Purchase Price is hereby acknowledged and shall be applied to the final purchase price, with the deposit being be non-refundable unless the Farm fails to deliver said animal in accordance with

Each deposit shall be credited towards the total Purchase Price upon Processor validating the Hanging Weight of the Cattle.

The final balance for the Purchase Price of the animal product will be determined as outlined above. Final payment is due within <u>five</u> days after the Buyer is notified of the hanging weight and prior to processing by the processor. Any unpaid balance after the due date may result in the loss of each deposit and forfeiture of the ability to purchase an animal.

With respect to Family Package, an <u>Additional Deposit of one-third of the Purchase Price</u> shall be paid to Farm not less than five (5) days from notice being provided to Buyer by the Farm as to the scheduled date of processing and prior to Transportation and Delivery of Cattle to Processor.

The final balance for the Purchase Price is due within five days after the Buyer is notified by the Farm that Processor has completed processing and beef is available for pickup by Farm. Any unpaid balance after the due date may result in the loss of each deposit and forfeiture of the ability to purchase.
